A RESOLUTION ESTABLISHING THE REAL ESTATE TAX MILLAGE, WAGE TAX, LOCAL SERVICES TAX AND REALTY TRANSFER TAX FOR THE YEAR 2022

BE IT RESOLVED, by the Borough Council of the Borough of Clarks Green that the Real Estate Tax millage for the calendar year 2022 be established at fifteen (15) mills for each dollar of assessed value or the sum of \$1.50 on each one hundred dollars of assessed valuation, and establishing the Wage Tax at one-half of one percent (0.5%), the Local Services Tax at fifty-two dollars (\$52.00), and Real Estate Transfer Tax at one percent (1%) for the calendar year 2022.
